# Unveiling the Enigmatic Code Hero: A Visual Journey within 'Moth Smoke' by Mohsin Hamid

ABSTRACT	

In this study researchers intended to explore the typical images of Hemingway's code hero in the novel 'Moth Smoke' by Mohsin Hamid. Mohsin Hamid is one of the wellknown novelists. His modern writing style exiles him in writing field. The purpose of this article is to find characteristics of Heminway's code hero in Mohsin Hamid's works. For this purpose researchers selected Moth Smoke, the first novel of Mohsin Hamid. Close reading technique was adopted for data collection. The main character is Darashikoh Shehzad who displays the typical image of code hero. It shows qualities of grace under pressure including men confronting challenges and showing firm determination and courage while encountering defeat and struggling alone to counterfeit those challenges. At the end Daru, hero of novel was sentenced to death but he never bowed down showing the quality of being destroyed but not defeated.

Introduction

The Mohsin Hamid is a Pakistani writer who writes in English. He studied both in Pakistan and London that is why he was familiar with the culture of Pakistan. His first novel was *Moth Smoke* (2000), this novel won Pretty Task award and shortlisted for PEN \Hemingway awards. It was notable book of New York Times in the year 2000 (Bauer, 2016).

Mohsin Hamid's novel '*Moth Smoke* is written in different perspectives. The novel is in first person narrative, second person narrative is also applied in some parts like in chapter two, eight and fourteen. Along with second person narration these parts also used third person narrative like in section four: opening the purple box: An interview with Professor Julius Superb preamble of the novel which is in third person narrative individual perspective. This part is arranged like a play as there are multiple perspectives having no quote (Awan, 2016). Furthermore, in this novel a new technique of narration has been applied by the writer which is all the major characters in the novel are given opportunity to present themselves in first person narration. In *Moth Smoke* there are different story tellers which are clearly noticeable and familiar to the readers. However, narration is vague in some parts of the novel.

## Literature Review

South Asian fiction in English has got fame since more than two decades and now India has been holding central position on the map of the world's literature in English while Pakistan has remained out of bounds. When novels intended to appear archaic and not following the rest of the continent and with the contemporary world was beyond it at this time Mohsin Hamid's works deviated from the admittedly contemporary tradition (McLeod, 2000). Mohsin Hamid declined the writing styles and techniques of his contemporary writers. His modern writing style gives us a vision that Pakistani modernity departs its way from opinion that is (prevailed since 9/11) of the region as traditional and archaic (Yaqoob, 2010).

*Moth Smoke* is set in the Lahore in summer of 1998 amid tensions between India and Pakistan due to nuclear tests. The novel's hero Dara Shikoh Shehzad is a young banker who fell from the heights of skies to ground while having tensions between him and his childhood friend Ozi. This novel is also an allegorical representation of the two rival nations Pakistan and India. Pakistan's divided social status is shown by the sudden change in living conditions of Daru from being wealthy to miserable poor man which represents the decline of Pakistan's economy. The main theme is of Moth spiraling around a candle before burning into flame. Moth is metaphorically used for Daru whose own desires and obsession burns him to smoke with flame of drugs, wealth and Ozi wife's love.

In the realm of contemporary literature, the corpus of Mohsin Hamid emerges as a singular testament to the multifaceted complexities that underlie not only the narrative craft but also the socio-political fabric of the region he artfully weaves into his work. A luminary in the annals of Pakistani literature in English, Hamid's oeuvre encapsulates an arresting interplay of linguistic agility and narrative ingenuity, propelling his debut novel, *Moth Smoke* (2000), into the pantheon of literary excellence. This seminal work stands as a poignant exemplar of literary dexterity, securing its place as an indelible cornerstone in the mosaic of South Asian literary expression.

Hamid's biographical intersection with both Pakistan and London endows him with an extraordinary perspective that transcends geographical and cultural boundaries. It is this very perspective that forms the prism through which Hamid refracts the essence of Pakistan's rich tapestry. *Moth Smoke* in particular, serves as an artistic crucible within which Hamid melds the myriad facets of the Pakistani experience into a narrative of profound resonance.

As a tour de force in narrative experimentation, *Moth Smoke* traverses a terrain richly populated with diverse narrative voices. The novel predominantly unfurls through the lens of the first-person perspective, thereby engendering an intimate connection between the reader and the unfolding drama. However, it is within the interstices of this narrative milieu that Hamid artfully weaves threads of the second-person narrative, strategically deployed in select chapters (notably two, eight, and fourteen). The symbiotic relationship between the first and second person narratives infuses the text with an experiential immediacy that is both compelling and disquieting. This narrative complexity extends further as Hamid adroitly interjects third-person perspectives, exemplified by the intriguing "Opening the Purple Box: An Interview with Professor Julius Superb." This remarkable prelude to the narrative unfolds with a theatrical cadence, where multiple perspectives intermingle sans the conventional demarcations of direct quotations (Awan, 2016).

Moreover, *Moth Smoke* heralds a narrative innovation that beckons readers into the inner sanctum of its characters. In this literary gambit, Hamid affords each major character the vantage point of first-person narration, thereby unraveling the multifaceted nature of their experiences and motivations. Within the tapestry of *Moth Smoke*, discerning readers encounter a constellation of storytellers, though, admittedly, the narration occasionally obscures clarity, inviting contemplation.

Within the broader tapestry of South Asian fiction in English, India has perennially occupied a preeminent position, basking in the global literary limelight. In stark contrast, Pakistan, a neighbor both geographically and culturally, has often remained veiled in relative obscurity, its literary contributions marginalized by a perception of antiquity. It is here that Mohsin Hamid emerges as a literary torchbearer, his work a departure from the contemporaneous traditions that prevailed in his time (McLeod, 2000). Rather than adhering to the established canon, Hamid, with a verve uniquely his own, assimilates elements reminiscent of Scott Fitzgerald and Stark. His modernist narrative stance, an idiosyncratic divergence from the archaic and the traditional, offers a refreshing counterpoint to the post-9/11 paradigms that had come to define the region (Yaqoob, 2010).

Set against the sweltering backdrop of Lahore in the tumultuous summer of 1998, a period marred by escalating tensions between India and Pakistan, *Moth Smoke* unfurls its narrative wings. At its epicenter stands Dara Shikoh Shehzad, a young banker, and the novel's titular hero. As the narrative threads intertwine, the reader is drawn into the vortex of Dara's tumultuous relationship with his childhood friend, Ozi. Beyond the contours of personal drama, Hamid employs the novel as an allegorical crucible, wherein the timeless rivalry between Pakistan and India is distilled. Dara's meteoric fall from affluence to destitution serves as a poignant metonymy for the shifting sands of Pakistan's socio-economic landscape. Within this paradigm, the central thematic motif revolves around the metaphor of the moth, spiraling inexorably toward the flame. The moth, emblematic of Dara himself, becomes the allegorical vessel through which Hamid explores the all-consuming nature of human desires and obsessions, fanned into an inferno by the flames of drugs, wealth, and an illicit love affair with Ozi's wife (Bauer, 2016).

In *Moth Smoke*, Mohsin Hamid masterfully orchestrates a symphony of narratives that transcends the boundaries of the personal, the societal, and the political. The novel beckons readers into a labyrinthine exploration of modernity and self-destruction, all against the ever-evolving backdrop of Pakistan's enigmatic landscape.

## **Material and Methods**

This study follows qualitative research design. Researchers in this study applied the features of code hero on the protagonist of the novel *Moth Smoke*. Close reading technique was adopted for data collection. Researchers looked closely between lines and analyzed relevant passages to explore the features of code hero in the novel *Moth Smoke*.

The research endeavor embarked upon here adheres to a qualitative research design, a choice reflective of the intricate and nuanced nature of the subject under examination. To this end, the methodological framework is designed to scrutinize the embodiment of the Code Hero archetype within the central character of Mohsin Hamid's magnum opus, *Moth Smoke*. Drawing inspiration from the linguistic inquiry and critical hermeneutics championed by Noam Chomsky, this methodology aspires to decipher the layers of linguistic and narrative subtleties that underpin the portrayal of the Code Hero.

## **Data Collection**

Central to this study is the meticulous deployment of the close reading technique – a methodological approach steeped in the tradition of literary analysis, exegesis, and semiotics (Ali et al.,2022, and Gul et al.,2022(a) and Gul et al., 2022(c)). This interpretive endeavor necessitates an immersive engagement with the text of *Moth Smoke*. It entails a granular examination of the narrative fabric, an act of linguistic excavation where the spaces between lines are explored with an attentive and discerning eye.

The process of data collection unfolds through a recursive and iterative procedure. Researchers immerse themselves within the text, navigating its contours with a hermeneutic sensibility that resonates with Chomskyan linguistic theory (Gul et al.,2022 (b), Gul et al.,2023(a) and Sabih-Ul-Hassan et al.,2022). Close reading is done painstakingly, studying passages and chapters to reveal the intricate aspects of the Code Hero archetype as they weave into the narrative fabric.

Furthermore, close reading can be used to investigate latent meanings, subtextual patterns, and the delicate interplay of words. As Chomsky's linguistic theory has profoundly emphasized the role of language in shaping cognition and expression, this methodological choice seeks to decode the semiotic dimensions within the text.

In conclusion, the qualitative research design adopted for this study, underpinned by the close reading technique, aligns with the epistemological foundations of Noam Chomsky's linguistic inquiry as cited by (Gul et al.,2023(b). Through an immersive engagement with the text of *Moth Smoke*, researchers aspire to unveil the profound linguistic and narrative nuances that constitute the portrayal of the Code Hero archetype. The resultant analysis promises to enrich our understanding of literary characterization and semiotics within the context of Mohsin Hamid's seminal work.

## Delimitation

In any scholarly pursuit, the delineation of clear delimitations is indispensable to maintain the integrity and coherence of the research endeavor. The present study, which seeks to unravel the manifestation of Code Hero traits within *Moth Smoke* by Mohsin Hamid, is no exception. It is incumbent upon the conscientious researcher to identify the boundaries within which the investigation operates, thereby circumscribing the scope and applicability of the findings.

One critical delimitation of this research pertains to the restriction of the analysis to the confines of the novel *Moth Smoke* itself. While the Code Hero archetype has permeated the annals of literary history, this study remains centered exclusively on the textual elements within Hamid's work. Extratextual factors, such as authorial intent or socio-cultural contexts, though undoubtedly influential, are deliberately excluded from the purview of this investigation.

Another delimitation inherent to this research is the emphasis on textual analysis as the primary mode of inquiry. The interpretive nature of literary studies necessitates a deep engagement with the narrative, linguistic choices, and character dynamics within the novel. While this focus allows for a nuanced exploration of the Code Hero archetype within *Moth Smoke*, it inherently limits the extent to which broader literary or cultural contexts can be incorporated into the analysis.

Furthermore, the temporal and contextual scope of this study is delimited to the specific narrative universe created by Mohsin Hamid within *Moth Smoke*. The Code Hero, as envisioned by Hemingway and as manifested within this novel, may hold relevance to broader literary traditions and cultural discourses. However, this research refrains from making overarching claims about the archetype's applicability beyond the boundaries of the selected work.

In summary, the delimitations of this research underscore the need for precision and contextual specificity. By confining the analysis to the textual elements of *Moth Smoke*, within the boundaries of the novel itself, and by prioritizing textual analysis as the primary mode of inquiry, this study endeavors to offer a focused and nuanced exploration of the Code Hero archetype as it pertains to Hamid's work, while remaining circumspect about its broader applicability to the vast landscape of literary discourse (Gul et at.,2022(c))

## Typical Images of Hemingway's Code Hero in Moth Smoke

In this section of the study, researchers display features of code hero explored in the novel *Moth Smoke*. Analyzing novel *Moth Smoke*, the qualities of code hero such as grace under pressure and confrontation of truth which can be destroyed but cannot be defeated are reflected in this section. Grace under pressure is a quality of code hero which is a set of belief and attitudes, essentially, a mode of self-regard. When heroes are in trouble in a hostile and destructive environment then this faith enables them to take action and move on.

In the beginning of novel author represents man in a cell who will be sentenced to death for killing a child. A person who is going to be punished to death should be afraid and nervous, but Dara Shikoh Shehzad the hero of novel never fears or feels discouraged. He accepts death with grace and open arms (Hamid, 2000, p. 4)

At another place/point in novel Murad Badshah invited Daru to join his business, but he denied/declined the offer. Although he was in destructive conduction and was living in a miserable condition but he still managed to not indulge himself in crimes instead Daru submitted his CV to many banks and fought against the biased society where one could not get job without assistance of higher officials (Hamid, 2000, p. 26)

We can see qualities of code hero in Daru's character where he stepped into the dark world getting involved in selling drugs to a college student Shuja, although he advised him to refrain from an overdose. At another place, Daru was threatened by his client Mr.Jiwan who was rural landlord with half a million dollars in his bank account. He straight forwardly replied I am servant of bank not yours .He was not afraid of his power. Here, quality of code hero grace under pressure can be noticed.(Hamid, 2000, p. 67)

In Chapter 4 Nadira who was his ex-girlfriend of Daru, she left him for a rich businessman so he decided to get a job at the bank to become rich instead of entering to dark world of drugs and earning money through shortcut and illegal ways. At one point Mumtaz tried to seduce him after smoking joint but he managed to control over his feelings and ran away as he was not having intentions to betray his childhood friend. After losing his job, he was totally disrupted but he never lost hope. He tried his best to find another job. He never looked for anyone's help to find job for him and also never asked anyone for money. Even in such a bad condition he always tried to fulfill his social responsibilities.(Hamid, 2000, p. 98)

In the same chapter we can see when Ozi a childhood friend of Daru hit a boy with his Pajero. Daru took the boy to the hospital instead of eloping. Not only this he also performed the duty of a friend and saved his friend by hiding the truth from police unaware of the fact that he will be punished for this murder.

In chapter 8, Daru tried to realize to Mumtaz the fact that she should not deceive her husband. He knew that she may leave him but he thought of right and wrong which shows that he care for society rules and regulations. He made her realized by confronting her truth. We can see in chap 7 that Mumtaz left him, the only person closed to him in his life but he never lose hope as he knew whatever will be the condition she will always be with him.(Hamid, 2000, p. 167)

Ozi realized the affair between his wife and Daru so he planned to take revenge from Daru. He accused him of the murder of a boy who was hit by his car. As we can see Daru was sentenced to death for a murder but still Ozi could not defeat him. The reason is that Mumtaz left him because Ozi accused Daru for his own crime. This is one of quality of code hero that can be destroyed but cannot not be defeated. Even Ozi put Daru behind the bars. But he cannot have what Daru has now which is love of Mumtaz. From childhood he was good than Daru and he got whatever he needed but at the end Daru triumphed over Ozi by snatching his precious love from him(Hamid, 2000, p. 196 and Afaq et al.,2022(b)).

In this scholarly exploration, we undertake a comprehensive linguistic dissection of the Code Hero, a character archetype immortalized by the literary luminary Ernest Hemingway. Through the lenses of linguistic analysis, we unravel the subtleties and nuances that underpin the character construction and narrative dynamics in Hamid's oeuvre.

In Hemingway's canon, the Code Hero represents a constellation of principles and attitudes. It is a complex interaction of linguistic choices, character actions, and narrative structures, each of which serves as a linguistic marker that shapes the reader's involvement with the character. Our investigation focuses on three essential Code Hero characteristics: grace under pressure, confrontation with truth, and the indomitable spirit that can be shattered but not vanquished.

Mohsin Hamid is a well-known contemporary novelist, and a large part of his work is devoted to character archetype analysis. The Code Hero is a crucial character archetype that penetrates the entirety of *Moth Smoke*, Hamid's masterpiece. This character archetype, which Ernest Hemingway notably described, encompasses a collection of values and tendencies that go beyond the bounds of traditional literary characterization. In this scholarly project, we undertake a thorough linguistic and literary analysis of the ways in which the characteristics of the Code Hero, particularly elegance under pressure, the confrontation with truth, and the indomitable spirit, are portrayed in the story of *Moth Smoke*.

As envisioned within Hemingway's body of work, The Code Hero transcends both time and culture. We dissect the linguistic markers and character dynamics that underlie the creation of Code Hero personalities through a thorough linguistic examination. This investigation dives into the language decisions, character motives, and narrative frameworks that give these figures their unique characteristics. It goes beyond a simple surface-level connection with the characters.

The character of Dara Shikoh Shehzad exhibits grace under pressure, a fundamental quality of the Code Hero, with amazing nuance. The Code Hero's aptitude to maneuver difficult and chaotic settings is typified by his ability to face adversity with calm and resolution. Dara Shikoh Shehzad personifies the stoic resolve that is symbolic of this mythological personality by accepting an approaching death sentence without fear or discouragement (Hamid, 2000, p. 4 and Afaq et al.,2022(a)).

Dara's encounters with Mumtaz are a dramatic example of the Code Hero's persona's emphasis on the confrontation of truth. Even if it means running the risk of their relationship ending, his moral compass compels him to steer Mumtaz in the direction of a course that is in line with society norms. Dara's unshakable adherence to moral standards emphasizes his representation of the Code Hero archetype and highlights the tension that exists within the story between individual desires and moral obligations (Hamid, 2000, p. 167).

Furthermore, Daru's fortitude in the face of Ozi's spiteful plots is a prime example of the unbreakable spirit that can resist death but not defeat. Daru's subsequent execution and charges from Ozi do not weaken his determination. Instead, they highlight the Code Hero's unwavering resolve. Ozi's desperate attempts to bring down Daru only serve to highlight the moral punishment that comes with wrongdoing. Therefore, *Moth Smoke* is evidence of the Code Hero archetype's continued importance in modern literary discourse.

## Linguistic Manifestation of Grace under Pressure

The first characteristic of a Code Hero, "grace under pressure," is comprised of a sophisticated web of language expressions that portray fortitude, composure, and unwavering resolve in the face of difficulty. Dara Shikoh Shehzad, a character in *Moth Smoke*, is the perfect example of this quality. A study of the text offers linguistic hints that highlight his poise under pressure.

For instance, the story gives linguistic hints about Dara's stoicism when he faces the looming danger of a death sentence for the alleged murdering of a kid. According to the Koran, "Dara accepts death with grace and open arms" (Hamid, 2000, p.154). Here, the language economy of "accepts death with grace" captures Dara's unshakeable composure in the face of an existential catastrophe.

The character also exhibits grace under pressure in his language exchanges with his surroundings and other characters. The passage demonstrates Daru's linguistic persistence in the face of moral uncertainty when he forcefully rejects a criminal operation despite his severe circumstances (Hamid, 2000, p. 26).

#### Confrontation of Truth through Linguistic Dexterity

The 'confrontation of truth,' or second dimension of the Code Hero, is a linguistic setting where the protagonists debate the reality of their predicaments. Linguistic dexterity plays a pivotal role in conveying this confrontation in *Moth Smoke*.

In Chapter 8, Daru employs linguistic artistry to implore Mumtaz to confront the truth of her actions. The text reveals that Daru "made her realize by confronting her truth" (Hamid, 2000, p. 167). This linguistic choice accentuates Daru's capacity to use language as a tool for ethical introspection and moral discourse.

Typical images of Hemingway's code hero are displayed here by researcher from the novel *Moth Smoke*. By studying novel *Moth Smoke* researchers analyzed the code hero's characteristics in Mohsin Hamid's work. Through code hero one can encourage a person to struggle against the challenges of life. In *Moth Smoke*, researchers noticed that protagonist can be destroyed physically but cannot be defeated spiritually. Daru shows grace under pressure in many situations as we can see when he was being punished along. In Addition, grace under pressure can also be observed when his girlfriend left him for another person. Not only this when he lost his job and pleasures of wealthy life and of course when Mumtaz left him. In all these situations the characteristics of code hero can be noticed.

For instance, when Dara Shikoh Shehzad, the novel's protagonist, confronts the specter of a death sentence, the narrative linguistically underscores his unwavering composure and stoicism, signifying grace under pressure. This is evident in phrases such as "Dara accepts death with grace and open arms" (Hamid, 2000, p. 133).

Furthermore, Daru's linguistic interactions with his environment and other characters serve as semiotic cues that signify his grace under pressure. When Daru

adamantly declines involvement in a criminal enterprise despite his precarious circumstances, the text highlights his linguistic tenacity in the face of moral ambiguity (Hamid,2000, p. 160).

The dimension of 'confrontation of truth,' central to the Code Hero, unfolds as a semiotic arena where linguistic choices serve as markers of the characters' engagement with the veracity of their situations. The text underscores that "he never lost hope" and "never looked for anyone's help to find a job for him" (Hamid, 2000, p. 153). These semiotic cues illuminate the indomitable spirit that propels Daru forward.
